At Tidy Caravans, we are committed to safeguarding and preserving the privacy of our visitors, clients and associates. This Privacy Policy explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site. This Policy is reviewed and updated from time to time, so please do review this Policy regularly.

### **Information We Collect**

In running and maintaining our website we may collect and process the following data about you:

1. Information about your use of our site including details of your visits such as pages viewed and the resources that you access. Such information is purely statistical and may include traffic data, location data and other communication data, but cannot be used to identify you personally.
2. Information provided voluntarily by you (For example, when you register for information or make a purchase.)
3. Information that you provide when you communicate with us by any means.

### **Use of Cookies**

Cookies provide information regarding the computer used by a visitor. We use cookies where appropriate to provide our reservation management service. Any information gathered via the use of cookies, or indeed otherwise, will not identify you personally, and is only used to provide our web service. By continuing to use the Tidy Caravans website, it is assumed that you accept and understand our Cookie Policy.

You can adjust the settings on your computer to decline any cookies if you wish. This can easily be done by activating the reject cookies setting on your computer. If you choose not to allow cookies, certain features of our website may not work correctly. You may experience problems with the reservation management system on the Tidy Caravans website through denying the use of cookies.

Our advertisers may also use cookies, over which we have no control. Such cookies (if used) would be downloaded once you click on advertisements on our website. We do not accept any liability for any action or consequence whatsoever, either through viewing advertisements on our website or through the use of any advertiser's own websites.

### **Use of Your Information**

We use the information that we collect from you to provide our services to you. In addition to this, we may use the information for one or more of the following purposes:

1. To provide information to you that you request from us relating to our products or services.
2. To provide information to you relating to other products that may be of interest to you. Such additional information will only be provided where you have consented to receive such information.

3. To inform you of any changes to our website, services or goods and products.
4. If you have previously purchased goods or services from us we may provide to you details of similar goods or services, or other goods and services, that you may be interested in.

Where your consent has been provided in advance we may allow selected third parties to use your data to enable them to provide you with information regarding unrelated goods and services which we believe may interest you. Where such consent has been provided, it can be withdrawn by you at any time.

### **Storing Your Personal Data**

In operating our website it may become necessary to transfer data that we collect from you to locations outside of the European Union for processing and storing. By providing your personal data to us, you agree to this transfer, storing or processing. We do our utmost to ensure that all reasonable steps are taken to make sure that your data is treated and stored securely.

Unfortunately the sending of information via the internet is not totally secure and on occasion such information can be intercepted. We cannot guarantee the security of data that you choose to send us electronically. Sending such information is entirely at your own risk.

### **Disclosing Your Information**

We have a legal obligation to provide the Kingfisher Park Office with full details of all occupants of caravans on site at any point. This means that the information you provide at the point of booking your holiday, must be passed on to the Kingfisher Park Office.

Other than this, we will not disclose your personal information to any other party other than in accordance with this Privacy Policy and in the circumstances detailed below:

1. In the event that we sell any or all of our business to the Buyer.
2. Where we are legally required by law to disclose your personal information.
3. To assist in fraud protection and reduce the risk of fraud.
